# **4.1** Library Strategic Initiatives Plan 2014 – Year End Report

The Library Director spoke to her written year-end report on achievements related to the Library's Strategic Initiatives Plan for 2014. She indicated that very good progress had been made in most areas, and that items that were not fully completed would be carried forward to 2015. Trustees thanked staff for their excellent work and acknowledged, in particular, the innovative and diverse range of programs now on offer.

# Library Activity Statistics 2014

#### 4.2 Library Activity Statistics 2014

The Library Director spoke to a report highlighting key library activity statistics for 2014 and including five year trend detail. Overall statistics are trending upwards over 2013 including: a 5% growth in number of items borrowed (total 631,095 items); a 17% increase in the number of inperson library visits (total 337,000 visits); a 20% increase in the number of reference questions answered (total 33,000 questions); and a 52% increase in program attendance (total 13,600 attendance).
